Questions to the Muslim section of our community

Some issues are not helped by unfounded, ill-informed comments by third parties which are based on no more than wishful thinking.

For that reason Briefing Notes now focusses on the Parent Council meeting to be held on Wed 13th. night and seeks answers to the following questions:-

- 1. The names of the individuals who identified the EHS campus as a potential site to the Muslim community.
- 2. Do those seeking to acquire the EHS campus site understand that as we speak, ERC are spending £1+ million on that very site and that money will have to be recovered in addition to the land value? That, contrary to the expectations of Dr Khan and Prof Hussain makes it the single most expensive site in Newton Mearns (NM) and ERC have a duty to the public purse which cannot be circumvented despite the promises of certain politicians who are leading the ERMEC/ERCL camps by the nose up a blind alley.
- 3. There are a number of far superior and much cheaper sites now within a short distance of the EHS campus.
- 4. To date ERMEC and Prof. Hussain have remained hidden from public scrutiny by refusing to engage with NMCC who are a statutory consultee on planning matters and are totally opposed to the EHS campus being broken up. This reflects the views of NM residents, both Muslim and non-Muslim with the exception of Dr Khan and his one aide.
- 5. The NM Muslim residents who have contacted NMCC are unanimously opposed to the EHS campus break-up plan. Prof Hussain is not a NM resident. NMCC have heard from residents at three

public meetings where the public included both Muslim and non-Muslims and not one attendee has yet supported the break-up of the EHS campus.

- 6. The majority of attendees at Tuesday night's (12th Nov) Muslim only meeting have not heard both sides of the story nor had the opportunity to do so as contrary to the stories ERMEC and ERCL put out of community engagement, they refuse to share a platform with non-Muslim community reps. The consequences that flow from this are potentially the destruction of the excellent NM inter-community relations. This potential damage is being brought about by outsiders to Newton Mearns.
- 7. Again next Monday's WEC/WET/ERMEC meeting for the wider community has wilfully refused to invite NM community reps such as NMCC to attend as invited speakers. What are they so afraid of? This is not community engagement, this is community manipulation and censorship.
- 8. With at least 25 Mosques in operation across the greater Glasgow conurbation we have seen no evidence that a mosque of the scale and size such as that proposed by ERMEC will be sustainable or even fundable and the last thing anyone needs is another Cumbernauld mosque failure.
- 9. Having seen the joint statement of Tuesday the 11th. Nov. from the Muslim groups, it's contents are highly questionable as only a week ago both ERMEC, ERCL and other groups were adamant they could and would never co-operate over a mosque. What's changed?
- 10. No-one has yet shown BN anything to support the lie that the site avidly pursued by ERMEC and co. is NOT an integral part of the EHS campus. Prove us wrong by producing evidence to support this nonsensical claim.

The Eastwood High Parent Council meeting on Wednesday night must deliver answers to these points or be judged as a wasted opportunity. Those attending must not allow the opportunity to question to be denied to them. For that reason it is imperative that the attending community are given the opportunity to speak and question those sharing the platform currently billed to include Hussain, Fletcher and Macintosh.

Gentlemen,

I write to you as Chairman of Newton Mearns Community Council. NMCC is greatly concerned at the various statements each of you have issued with regard to the specific location of the mosque site you are promoting within the Eastwood High School campus.

To establish a clear understanding as to the location of the site, we the community council invite the three of you, together with any other ERC councillors and representatives from the planning department, to have a brief but hopefully productive meeting on site this weekend, either Saturday or Sunday at a time of your convenience. For the avoidance of doubt, community council members will make themselves available at whatever time is convenient for your good selves. As this letter is an open letter we have cc'd in the other ERC Cllrs so they know they are included within this invitation.

In view of Jim Murphy's London based commitments we are happy to split the invitation into two separate site visits for the convenience of those more locally based.

There are other far more suitable sites available but firstly we must establish that we all understand the specific location of the piece of ground everyone is actually referring to and the implications inherent for our new school campus and the pupils who study there.

Further I have attached two drawings, the first being from ERC Planning Dept and the second is from ERMEC. Hopefully you will understand the outrage in the community at any suggestion of removing this piece of ground from the school campus. I need hardly explain that access to the marked area would sterilise the land between the marked site and Capelrig Rd. to enable access and prevent the site from being 'land locked."
