Information Request under the Freedom of Information (Scotland) Act 2002

Thank you for your request for information relating to Councillors' of East Renfrewshire having Council tax arrears, which I received on Monday 3rd April 2017.

The Council considers that this information is the personal data of the individual elected members. As such, it has to be considered under the terms of the Data Protection Act 1998. There is no legal basis for releasing this information to a third party under this Act and it would therefore constitute a breach of this Act. Under Section 38(1)b of the Freedom of Information (Scotland) Act 2002 information is exempt from disclosure if its release would breach the DPA and I therefore have to refuse your request.

East Renfrewshire Council offers the opportunity to apply to the Council for a review of how we have dealt with your enquiry. If you wish to proceed to review, please apply in writing within 40 working days to:
