cost would be £399 plus VAT for the overnight stay, food, refreshments, access to the conference and all the activities of the awards ceremony. (Pre-Dinner Reception and Dinner Atrium)

#### = £478.80

Why is the claim £544? (Apparently as all three stayed an extra night)

When we look at Barbara Grants claim she has also submitted a 'green form' which is required for travelling and subsistence claims in respect of conferences.

Cllr Grant claimed £111.35 for using her car and that included £20 subsistence.

However the form indicates that she left home at 1pm on the 10/10/18 to undertake the 1 1/2 hour drive in order to be at the hotel for the commencement of the conference at 9.30 am on the 11th.

COSLA advised that anyone staying overnight the evening before would be charged £145 plus VAT = £174.

More than the £544.

The questions that arise are Cllrs Buchanan and O'Kane never claimed mileage? (Did they car share which would be great)

Why did Cllr Grant require to leave her home at lunch time (1pm), could she not have left after her tea (6pm), therefore not requiring to claim £20 for food?
