This is the site where the council is having a new nursery built. It is in early stages of being built and now the planners are alleging that a digger has damaged the roots of 12 trees, and as a result they require to remove them due to Health & Safety reasons. The 12 trees are all subject of a Tree Preservation Order (TPO). Council make these orders - They are made to protect individual trees, groups of trees or woodlands which have particular amenity value, make a significant contribution to the landscape or townscape or because there may be a potential threat to the trees. Deciding which trees qualify to become protected the local authority must ensure that the trees contribute to the amenity and attractiveness of an area and be under threat in some way. Either individual specimens or groups can be protected in a single Order. Re: We need your help!
Posted by Newsline - 18 Aug 2019 12:34 This is the group of trees concerned, around 40 very mature trees. (12 are of a species that require to be protected) However the 12 trees have tags on them and they are not all in the front row of the picture, many are behind other unprotected trees.

As you can see from the cut banking there are no tree roots exposed.

The strange thing about the ERC Planners application is that they have stated the public cannot object to the planning application.

Indeed the online application does not permit any objections.
It was only put onto the web site a few days ago and the fear is that they intend to rush this through as a Health & Safety issue.
However none of the trees have been barrier taped, no restrictions on walking up to and touching the trees, which are well outside the area of the building site.
No sign of any tree roots exposed.
So why the rush to remove 12 protected trees.
Of course the other question is, are the 12 the only ones that will be removed.
The others are not protected and can be removed by ERC if they wish.
